# ARTICLES OF INCORPORATION OF KWI-INDUSCO, INC.

The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

# ARTICLE I. CORPORATE NAME

The name of this corporation is: KWI-Indusco, Inc.

# ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this corporation, which is also the mailing address of the corporation, is 429 Talleyrand Avenue, Jacksonville, FL 32202.

## ARTICLE III. DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State of Florida.

## ARTICLE IV. PURPOSES

# ARTICLE V. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of \$1.00 par value common stock.

preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

#### ARTICLE VI. INITIAL REGISTERED OFFICE AND REGISTERED AGENT
