ARTICLE I - NAME

The name of this Corporation is Countrytime Pub, Inc.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

ARTICLE IV - CAPITAL STOCK
