ARTICLES OF INCORPORATION

OF

ESTHER H. HART ASSISTED LIVING FACILITIES, INC.

The undersigned hereby associate themselves together for the purpose of becoming incorporated and forming a corporation under the following charter or articles of incorporation:

ARTICLE I

The name of this corporation shall be:
ESTHER H. HART ASSISTED LIVING FACILITIES, INC.

ARTICLE II

Its principal place of business and office in the State of Florida is to be located in the County of Palm Beach, and branch offices may be established in such place or places in the State of Florida and in the United States and in foreign countries as may, from time to time, be authorized by the Board of Directors. The principal place of the corporation shall be

ARTICLE III

The corporation shall have perpetual existence.

ARTICLE IV

The number of Directors of this corporation shall not be less than 1, nor more than 5.

ARTICLE V

The following general provisions shall govern this corporation:

The time and place of the annual stockholders meeting shall be fixed and provided for in the by-laws and notice of same shall be given in one of the methods provided by law. - (d) To supervise and manage all classes of properties, income bearing or otherwise, for this corporation or for other persons, corporations and or associations; to act as agent, broker or attorney in fact, on a commission basis or otherwise, for any other person, corporation or association, to negotiate sales, leases, mortgage, deeds of trust and other encumbrances of properties of other persons, corporations and associations, real personal and mixed, wheresoever situated; and generally to maintain, conduct and carry on the business of real estate agent or broker.
