# ARTICLE I. Name and Initial Address

The name of this corporation is LUXURY HOMES AT WATERCREST, INC. and initial address of the corporation is 349 14th Avenue South, Naples, Florida 34102.

#### ARTICLE II. Duration

7-29-97

This corporation shall exist perpetually commencing on the date of execution and acknowledgment of these articles.

# ARTICLE III. Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

#### ARTICLE IV. Capital Stock

This corporation is authorized to issue 10,000 shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

### ARTICLE VII. Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VIII. Initial Board of Directors
