THE UNDERSIGNED, acting as sole incorporator of a corporation to be formed under the Florida Professional Service Corporation and Limited Liability Company Act (the "Act"), adopts the following Articles of Incorporation:

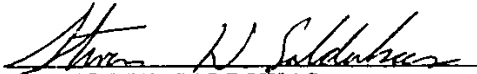
