

**ARTICLES OF INCORPORATION  
OF  
Done Rite Auto Repair, Inc.**

*The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.*

**ARTICLE I NAME**

*The name of the corporation shall be Done Rite Auto Repair, Inc.*

**ARTICLE II NATURE OF BUSINESS**

*This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.*

**ARTICLE III CAPITAL STOCK**

*The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having a par value of \$1.00 per share.*

**ARTICLE IV ADDRESS**

*The street address of the initial registered office of the corporation shall be 21701 Freeman Drive, Umatilla, Florida 32784 and the name of the initial Registered Agent for the corporation at that address is Lorraine M. Slocomb.*

**ARTICLE V SPECIAL PROVISIONS**




