

The Articles of Incorporation of CONTEMPORARY OPPORTUNITIES, INC. were amended by unanimous vote of the Shareholders and Directors of the Corporation on March 22, 2001, by deleting Article III, in its entirety, and by substituting in its place the following:

ARTICLE III

This Corporation is organized for the purpose of engaging in any activity or business permitted under the Laws of the United States and the State of Florida. Specifically, this Corporation shall operate as a non-public post secondary school as defined by Section 246.203(1) of the Florida Statutes upon obtaining the required license from the Florida State Board of Non-Public Career Education.
