ARTICLES OF INCORPORATION
OF

SPECIALIZED RESOURCES INTERNATIONAL, INC.

ARTICLE I.

The name of this Corporation shall be SPECIALIZED RESOURCES INTERNATIONAL, INC.

ARTICLE II.

This Corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III.

This Corporation is organized for the purpose of transacting any or all lawful business for which Corporation may be incorporated under Chapter 607 Florida Statutes, as now exists or may hereafter be amended.

ARTICLE IV.

This Corporation is authorized to issue 500 shares of stock at \$1.00 par value which shall be designated as common shares of stock.

ARTICLE V.

The street address of the initial registered office and the principal office address is 12 East McKey Street, Ocoee, Orange County, Florida 34761, and the initial Registered Agent of this Corporation is BEN GRIFFIN at 12 East McKey Street, Ocoee, Florida 34761.

ARTICLE VI.

This Corporation shall have one Director constituting the Initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the By-Laws; however there shall never be less than one Director nor more than five. The name and address of the initial Board of Directors of the Corporation is BEN GRIFFIN, 12 East McKey Street, Ocoee, Florida 34761,

and address of the Incorporator signing these Articles is BEN GRIFFIN, 12 East McKey Street, Ocoee, Florida 34761.

ARTICLE VII

The Corporation shall indemnify any officer or Director or any former Officer or Director to the full extent permitted by law.

ARTICLE VIII

The Corporation reserves the right to amend or repeal any provision contained in the Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subjectd to this reservation.

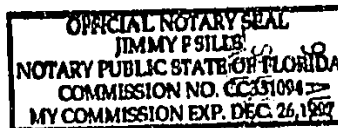
