ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

AND PRINCIPAL CORPORATE ADDRESS

The name of this Corporation is: PRODUCCIONES FUEGO LATINO, INC. TRANSLATION: LATIN FIRE PRODUCTIONS, INC.

ARTICLE II NATURE OF BUSINESS

ARTICLE IX SPECIAL PROVISIONS


