The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation shall be DRAKE-SMITH AUTO GROUP, INC. The principal place of business of this corporation shall be 1100 West Homestead Road, Lehigh Acres, Florida 33936.
