ARTICLE I

NAME

THE Name of the Corporation is RF SERVICES INC.

ARTICLE II

TERM OF CORPORATE EXISTENCE

The corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation by the Department of State.

ARTICLE III

PERMITTED ACTIVITY

The Corporation shall engage in any activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

AUTHORIZED SHARES

The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares of common stock with par value of \$1.00 each.

ARTICLE V

PREEMPTIVE RIGHTS DENIED

No holder of any shares of the Corporation shall have any preemptive right to purchase, subscribe for or otherwise acquire any shares of the Corporation of any class now or hereafter authorized, or any securities, exchangeable for or convertible into such shares, or any warrants or any instruments evidencing rights or options to subscribe for, purchase, or otherwise acquire such shares.

ARTICLE VI

PRINCIPLE OFFICE

The principal office of the Corporation is 14701 S. Beckley Sq., Davie, Florida 33325.

ARTICLE VII

REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation is 14701 S. Beckley Sq., Davie, Florida 33325. The initial registered agent at that address is MARCIA DUTRA GODINHO.

ARTICLE VIII

DIRECTORS

The business of the Corporation shall be managed by a Board of Directors consisting of not fewer than one person, the exact number to be determined from time to time in accordance with the By-Laws.
