ARTICLES OF INCORPORATION OF ENGIGRAPH, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE NAME

- 1.1 The name of the Corporation is **ENGIGRAPH, INC.**
