# **ARTICLES OF INCORPORATION**

OF

# PAINT-YOUR-POTTERY, INC.

## ARTICLE I

This corporation will be a Subchapter S corporation by the name of Paint-Your-Pottery, Inc.

# ARTICLE II

The nature of the business is to act to the extent permitted under Florida Statutes, Chapter 607 (1996 as amended), and to engage in every business permitted under the laws of the State of Florida and the United States.

### ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have at any time shall be One Thousand (1,000) shares of common stock of Ten Cents (\$0.10) par value per share.

# ARTICLE IV

The corporation shall begin business with a capital stock of not less than Five Hundred Dollars (\$500.00).

#### ARTICLE V

This corporation shall exist perpetually.

#### **ARTICLE VI**

Special provisions for the regulation in government for this corporation are:

# ARTICLE XIV

If all the directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the board of directors.
