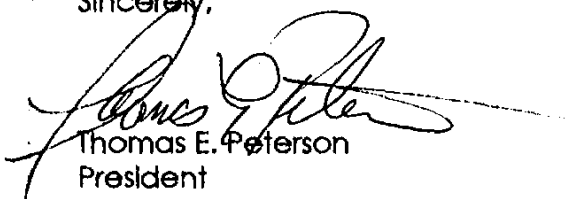
Upon advice received from my telephone inquiry this date, I am submitting the 1998 Corporation Annual Report along with the early filing fee of \$150.00.
