ARTICLES OF INCORPORATION OF

EUROFRUIT & JUICE PRODUCTS NORTH AMERICA, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is EUROFRUIT & JUICE PRODUCTS NORTH AMERICA, INC. and its principal office and mailing address is 10316 Kingfisher, West, Bradenton, Florida 34209.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on August 5, 1997.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV

Capital Stock
