

Pursuant to Chapter 607 of the Florida Statutes, the undersigned does hereby submit these Articles of Incorporation for the purpose of forming a profit corporation.

**Article I - Name and Principal Office**

The name of the corporation is **SITE MASTER, INC.** The corporation's principal place of business address and its mailing address is 11350 SW 3 St., Plantation, FL 33325-2904.

**Article II - Duration**

The duration of the corporation is perpetual.

**Article III - Purpose**

The corporation shall engage in any activity or business permitted under the laws of the United States and of the laws of Florida.

**Article V - Shares**

The corporation has the authority to issue an aggregate one thousand common shares of capital stock at .01 par value.

**Article VI - Commence of Business**

The corporation will commence once the corporation has issued at least one common share in exchange for one thousand dollars in cash, property, or services rendered.

**Article VII - Registered Agent and Registered Office**

The name of the corporation's first registered agent is John J. Malerba, EA, and his address is 8551 W. Sunrise Blvd., #102, Plantation, FL 33322-4007.

As registered agent, I accept service of process for the above corporation at the place designated in these articles of incorporation. I accept this appointment and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties.
