The name of this corporation is: Brad Richdale Direct, Inc.

***ARTICLE II - DURATION***

If not, these Articles shall become effective upon the date they are filed by the Department of State.



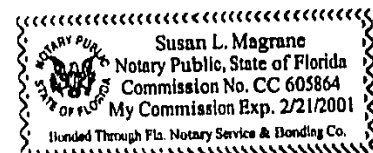
