The name of the corporation is:

ARTICLE X - AMENDMENT

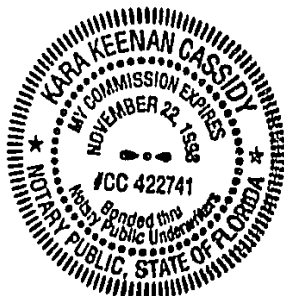


