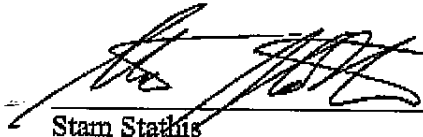

The action taken under this written consent is effective according to the above terms, not when the last shareholder signs this consent.

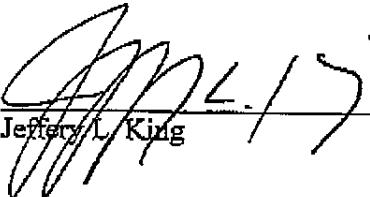
