Debts of the corporation have been provided for.

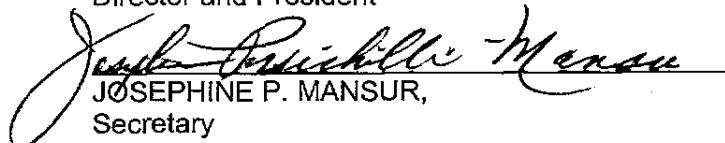
ARTICLE V NET ASSETS
