ARTICLE ONE

The name of the corporation is Premiere Foodservice Management of Southwest Florida, Inc. and the mailing address shall be P.O. Box 17752, Sarasota, Florida 34276.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) of the par value of one dollar (\$1.) each.


