ARTICLES OF INCORPORATION OF MASVI INTERNATIONAL, INC.

I, Amneris Monteagudo, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge, and ratify the following articles of incorporation for the purpose of creating a corporation under the laws of the state of Florida.

1. The name of this corporation shall be Masvi International, Inc.

2. The purpose of this corporation shall include the transaction of any and all lawful business for which corporations may be incorporated under chapter 607, Florida Statutes.
