OF

ARTICLE I--NAME

The name of this corporation is SOTE, INC.

ARTICLE II--DURATION

This corporation shall exist perpetually.

ARTICLE III--PURPOSE

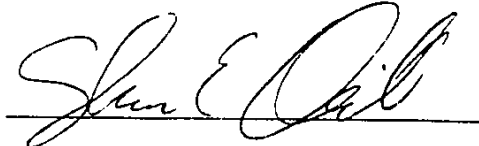

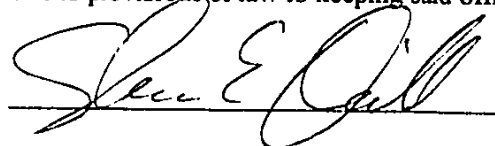
