ARTICLES OF INCORPORATION

The undersigned being a natural person, for the project of becoming a corporation under the laws of the State of Florida, and under the provisions of the Florida Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is FLORIDA KEYS FRESH DIRECT INC..

ARTICLE II

The general nature of the business to be conducted and carried on by this Corporation is:

- A. To engage in all phases and aspects of the fishing industry including, but not limited to the capturing, raising, processing, and the purchase, sale and distribution of fish and crustaceans.
