ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of this corporation is: TOWN PLAZA, INC.

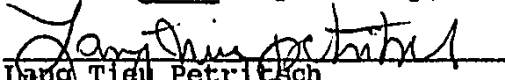
ARTICLE IX - BYLAWS

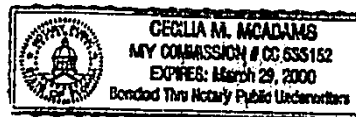
