ARTICLES OF INCORPORATION

OF

HANK'S BILLIARDS OF MIAMI, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTIÇLE I

The name of the corporation shall be: HANK'S BILLIARDS OF MIAMI, INC.
