ARTICLES OF INCORPORATION OF SURF NICARAGUA, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act and for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of this Corporation is SURF NICARAGUA, INC. The mailing address is: 407 6th Avenue South, Jacksonville Beach, Florida 32250.

ARTICLE II Duration

This Corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles, or upon filing with the Department of State of the State of Florida in the event these Articles are not filed within five (5) days, exclusive of legal holidays, after execution and acknowledgment.

ARTICLE III Nature of Business

This Corporation is organized for the purpose of transacting any or all business permitted under the laws of the United States or the State of Florida.

ARTICLE IV Capital Stock

The aggregate number of shares of capital stock which this corporation is authorized to issue is fifteen thousand (15,000) shares of Class A voting common stock, all of which shall be One Dollar (\$1.00) per share par value and twenty-five thousand (25,000) shares of Class B non-voting common stock, all of which shall be Five Dollars (\$5.00) per share par value.

ARTICLE V Initial Registered Office and Agent

The street address of the initial Registered Office of this Corporation is 444 Third Street, Neptune Beach, Florida 32266, and the name of the initial Registered Agent of the Corporation at that address is Joseph M. Glickstein, Jr.

ARTICLE VI Directors

This Corporation shall initially have three (3) Directors. The number of Directors may be increased or decreased from time to time by the Bylaws, but shall never be fewer than two. The names and street addresses of the members of the first Board of Directors of the Corporation are:

This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
