ARTICLES OF INCORPORATION

OF

SUN & DIAMONDS MOBIL CAR WASH, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation is: SUN & DIAMONDS MOBIL CAR WASH, INC.

ARTICLE TWO

The general purposes for which the corporation is organized are:
