### Article 1

### **Corporate Name**

The name of this corporation shall be "ATLAS COMMUNICATIONS HOLDING, INC."

### Article 2

### **Principal Office and Mailing Address**

### Nature of Corporate Business

The general nature of the business to be transacted by this Corporation shall be to engage in business for profit and is organized for the following general purposes:
