ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is IGLOO SPORTS, INC., and the principal address is 7200 U.S. Hwy 19, Room 732, Pinellas Park, FL 33781.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is 7200 U.S. Hwy 19, Room 732, in the City of Pinellas Park, County of Pinellas, Florida 33781. The name of its registered agent at such address is Donna L. Bollman.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.
