I am writing this letter to request reduction or abatement of the reinstatement fees for my corporation which was involuntarily dissolved, due to lack of UBR filings. My knowledge of this dissolution came to me almost by mistake, as it was revealed to me by a financial institution evaluating my business for a loan. I realize that it is ultimately the responsibility of the governing body of a corporation to maintain compliance of its business filings; however, I must admit that since I neither received the UBR nor notification of the dissolution of our company I believed that all my filings were being handled by my registered agent and attorney, Irving J. Gonzalez. Since I had been paying him professional fees, I thought this was included.

In fact, I honestly had no idea that we had to do more than just have an annual corporate meeting and minutes on file, until this past February when I received the UBR for another corporation (In The Zone Sports Enterprises, Inc. Document Number P00000005838) which we started in hopes of spinning off our internet business. I believe that we have proven to be responsible in our filing of our intangible taxes, our employer taxes and our corporate tax returns.

Hopefully you will be able to grant me this one time waiver. This issue has already created a financial hardship, as our business is extremely leveraged right now, and we have a very limited budget. If our only option is to pay the reinstatement fee as well the filing fees, totaling \$1200.00, we would be not be able to completely cover the expenses. I really do not need 2 corporations, so maybe it is possible to transfer the name and filing fee from In The Zone Sports Enterprises, Inc. Document Number P00000005838, to LuMarc, Inc P97000068961, change the fectitious filing, Authentics Registration Number G98110900066.
