

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
PTG OF BREVARD, INC.**

Paragraph 4 of the Articles of Incorporation of PTG of Brevard, Inc. was amended by the Corporation's Shareholders on march 21 2000. The Corporation is filing these Articles of Amendment to Articles of Incorporation pursuant to Florida Statutes Section 607.1006.

1. The name of the Corporation is PTG of Brevard, Inc.
2. Paragraph 4 of the Articles of Incorporation of the Corporation was amended to read

as follows:

**"Capital Stock.** The corporation is authorized to issue one million (1,000,000) shares, all of voting Common Stock having a par value of one cent (\$.01) per share."

3. The foregoing amendment to the Articles of Incorporation was voted on by the Shareholders of the Corporation entitled to vote on the matter and the number of votes cast by the Shareholders was sufficient for approval.
