ARTICLE I - NAME

The name of this corporation is Andrew Y. Winston, P.A.

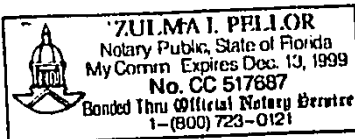
