The undersigned incorporator(s) hereby adopt the following Articles of Incorporation:

- I. CORPORATE NAME - FRANK BUTLER'S SPEED SHOP, INC.

- VI. EFFECTIVE DATE - The effective date of this incorporation shall be SEPTEMBER 1, 1997.

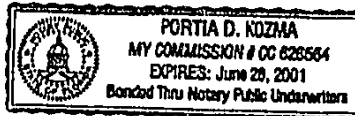


