ARTICLE VI



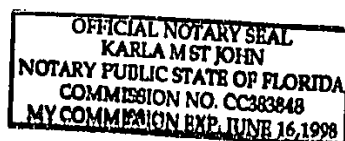

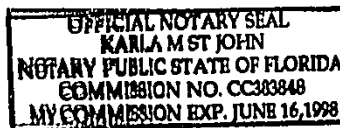
