ARTICLES OF INCORPORATION

THE UNDERSIGNED SUBSCRIBES TO THESE ARTICLES OF INCORPORATION,
COMPETENT TO CONTRACT, HEREBY FORM A CORPORATION UNDER THE
LAWS OF THE STATE OF FLORIDA.

ARTICLE ONE

CORPORATE NAME: THE NAME OF THE CORPORATION IS: STAT MEDICAL
BILLING SERVICES, PA.

ARTICLE TWO:

DURATION: THE CORPORATION SHALL EXIST PERPETUALLY UNLESS
DISSOLVED UNDER FLORIDA LAW.

ARTICLE THREE
