ARTICLES OF INCORPORATION

The undersigned, acting as the Incorporator of a Corporation organized under the laws of the State of Florida, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation is INTERNATIONAL MARKETING ALLIANCE, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation is organized as a Corporation for profit generally engaged in the business of exporting and importing, and otherwise for the purpose of transacting any or all related or collateral business permitted under the Laws of the United States of America and the State of Florida.

ARTICLES IV - CAPITAL STOCK

ARTICLE VI - INITITAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE VII - INITIAL BOARD OF DIRECTORS
