

ARTICLE I.
NAME

The name of the corporation is: PROTEX INVESTMENTS, INC.

ARTICLE II.
PRINCIPAL OFFICE

The principal office of the Corporation (or the mailing address) will be: 9500 N.W. 37th Court, Coral Springs, Florida 33065.

ARTICLE III.
DURATION

The corporation shall exist in perpetuity.

ARTICLE IV.
PURPOSE


**ARTICLE XI.


