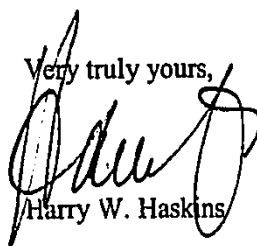

**ARTICLE I**  
**NAME**

The business of the corporation shall be managed by the shareholders of this corporation rather than by a Board of Directors.

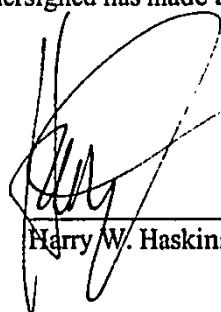
