ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, do hereby act as incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is
Lopez Transport Co., Inc.

ARTICLE II

The existence of the corporation shall begin upon its issuance of the corporate charter by the State of Florida.

ARTICLE III

The street address of the principal office of the Corporation is 7705 N. Orleans Avenue, Tampa, Florida, 33604.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one thousand (1000), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

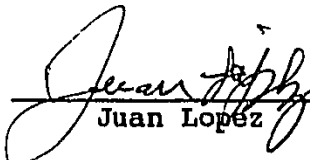

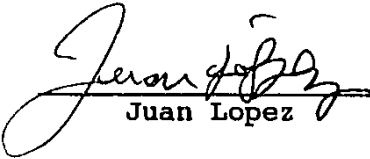
