Article I – Name

The name of this corporation: Sensorial Group, Inc.

Article II – Duration

This corporation shall have perpetual existence.

Article III – Purpose and Powers

This Corporation is organized for the purpose of and shall have the authority to transact and or all lawful business for which corporations may be incorporated under Chapter 607, Florida statutes, as presently enacted and as may be amended from time to time, including but not limited to the operation of: export & import of goods, wholesale & retail of tangible goods including mattresses & camping goods; manufacture of mattresses and sporting goods.

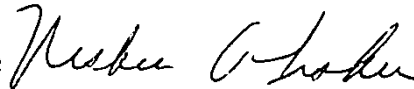

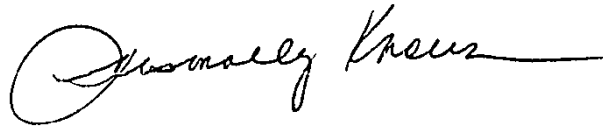
