# ARTICLES OF INCORPORATION

OF

#### ROMAI'S INC.

SECRETARY OF STATE ONE DIVISION OF CORPORATIONS

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

# **ARTICLE I**

The name of the corporation is ROMAI'S INC.

# **ARTICLE II**

The duration of the corporation is perpetual.

# ARTICLE III

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

### **ARTICLE IV**

The amount of the Capital Stock of this corporation shall be FIVE HUNDRED SHARES at ONE DOLLAR (\$1.00) par value, which said stock shall be non-assessable to be held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine. All of the Capital Stock shall be common stock.

# ARTICLE V

The corporation shall commence business upon filing with the office of the Secretary of State.

# ARTICLE VI

The principal place for the transaction of its business and the mailing address of the corporation shall be 2336 Everest Parkway Cape Coral, Florida 33904. That said corporation shall have the right and authority to do business at such other place or places within or without the State of Florida as the corporation may by resolution designate.

# **ARTICLE VII**

The corporation shall have a board of no less than one (1) director and the board may be increased to not more than four (4) directors. The number of directors each year may be determined by the shareholders at their annual meeting, or may be fixed by the By-Laws.

## **ARTICLE VIII**

The officers by whom the business of said corporation shall be conducted shall be a President, who shall be a Director, a Vice-President, a Secretary, and a Treasurer and such other officers, agents and directors who shall be chosen in such manner, hold their office for such term and have such powers and duties as may be prescribed by the By-Laws or determined by the Board of Directors.
