ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

ARTICLE II

The general nature of the business is real estate. The general purpose of this business is for commercial and residential sale of properties.
