OF

ARTICLE I
CORPORATE NAME

The name of this Corporation is: FAIRFIELD PRINTING & GRAPHICS, INC.

ARTICLE II
NATURE OF CORPORATE BUSINESS

This Corporation is organized for the following purpose or purposes: To own, lease, operate and in all respects engage in the business of printing and publishing and all related businesses and activities and to acquire by purchase or otherwise, sell, own, lease, construct, build, and improve real property; and to otherwise engage in investments of real estate and personal property of every class or discription and rights and privileges therein, wheresoever situate and all things related thereto including the improvement, development and management of said real and personal property and all things related thereto.
