The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the Corporation is **MULTIPLE CHOICE COMMUNICATIONS, INC.**

**ARTICLE II: DURATION**

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

**ARTICLE III: PURPOSE**

The Corporation may engage in any activities of business permitted under the laws of the United States of America and the State of Florida, including, but not limited to retail and wholesale sales of communication devices, services and related products.

**ARTICLE IV: CAPITAL STOCK**

The total number of shares of capital stock authorized to be issued by the Corporation will be ten thousand (10,000) shares having a par value of one dollar (\$1.00) per share. Each of the said shares of stock will entitle the holder thereof to one (1) vote at any meeting of the stockholders.

**ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT**

The initial registered agent and office of the Corporation will be Charles R. Kenner, 11905 Middlebury Drive, Tampa, FL 33626-2521. The initial address of the principal office of the Corporation will be 4306 W. Cayuga Street, Tampa, FL 33614. The Board of Directors may, from time to time, move the principal office to any other address.

**ARTICLE VI: INITIAL BOARD OF DIRECTORS**

The Corporation will have two (2) director(s) initially. The number of directors may be either increased or diminished from time to time by the by-laws. The name and address of each person who is to serve as a member of the initial Board of Directors is:




