ARTICLES OF INCORPORATION

OF

STEVEN D. SEDERHOLM, M.A., CCC/A, P.A.

The undersigned hereby execute and acknowledge these Articles of Incorporation in order to organize and incorporate a business for profit under the corporate name of STEVEN D. SEDERHOLM, M.A., CCC/A, P.A., at the initial business address of 1403 West Boynton Beach Boulevard, Suite 6, Boynton Beach, Florida 33426.

ARTICLE I - PURPOSES AND OBJECTS

The Corporation is formed pursuant to the Professional Service Corporation Act and for the purposes and objects of rendering the same professional services to the public that duly licensed audiologists are authorized to render. The Corporation may engage in the aforementioned business or specific profession and in any other transaction or business permitted under the United States and of this State.

ARTICLE 2 - DURATION

The duration of the Corporation is perpetual. Corporate existence shall commence effective July 7, 1997 or upon the filing of these Articles with the Secretary of State for the State of Florida.

ARTICLE III - REGISTERED OFFICE - AGENT

The name of the Registered Agent is Steven D. Sederholm and the street address of the Registered Agent is 1403 West Boynton Beach Boulevard, Suite 6, Boynton Beach, Florida 33426.

ARTICLE IV - NUMBER OF DIRECTORS

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

ARTICLE IX - BY-LAWS

The power to adopt, alter, amend or repeal the By-Laws shall be vested in the Board of Directors.

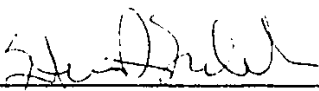
