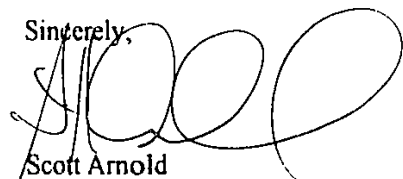

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of the corporation is Arnold's Pest Control Services, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in the transaction of any and all business permitted under the laws of United States and of this State.

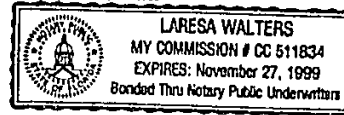
