ARTICLES OF INCORPORATION

OF

J&SCONCRETE OF BREVARD, INC.

ARTICLE I - NAME

The name of the corporation is J & S Concrete of Brevard, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on August 16, 1997, and at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSES

ARTICLE IV - CAPITOL STOCK

The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.
