## ARTICLES OF INCORPORATION OF F.I.A. LEARNING CENTER, INC.

The undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I NAME

The name of this corporation is F.I.A. LEARNING CENTER, INC. The mailing address is 661 NE 125<sup>th</sup> Street, North Miami, FL 33161.

## ARTICLE II DURATION

The duration of this corporation shall be perpetual.

### ARTICLE III GENERAL PURPOSE

This corporation is formed for the general purpose of furthering adult education.

The primary, but not exclusive, objective is to qualify eligible individuals for a high school diploma. Life experience and successful completion of competency-based examinations will be utilized to qualify each student. All evaluations, final determinations, and issuance of grade transcripts and high school diplomas will be done by a participating, fully-accredited high school. Although students often study on their own to pass exams, individual or class tutoring will be available for individuals requiring further instruction.

College credits are also to be offered through Cambridge University, England, through the A. P. Program, or other institutions with which we may affiliate. Classes may also be formed to instruct students in other areas of interest, such as computer skills, language proficiency, employment qualification and procurement, etc.

F.I.A. Learning Center, Inc. will not engage in any political activity other than that which is specifically necessary for its own existence and well-being, such as local zoning laws and taxation issues. The corporation is forbidden to make political donations or endorsements.

This organization shall not discriminate against any individual on the basis of race, religion, creed, gender, sexual preference, or age, except that a minimum age may be required for admission to most of our programs.

The corporation may engage in any other activities or business, as permitted under the laws of the United States and the State of Florida.

### ARTICLE IV CAPITAL STOCK

The aggregate number of shares of stock that this corporation is authorized to issue and have outstanding at any time shall be One Hundred Thousand (100,000) shares of one class of common stock with a par value of twenty-five cents (\$0.25) per share.
