The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**NAME AND PRINCIPAL OFFICE**

The name of this corporation is BOYD BROTHERS OF PENSACOLA, INC., and its principal office is located at 2280 North Ninth Avenue, Pensacola, Florida 32503.

**ARTICLE II**

**DURATION**

This corporation shall exist perpetually, commencing upon the date of filing of these Articles with the State of Florida.

### INITIAL REGISTERED OFFICE AND AGENT

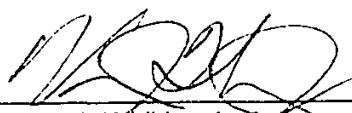
